Certification Staffing Assignment ELEMENTARY EDUCATION (K-6)

Elementary Education is the science or art of preparing individuals to teach all elementary subject matters including literacy and mathematics in the elementary grades, including kindergarten through grade six.

Grade-Level Scope of Certificate:

A person holding a valid Pennsylvania certificate for elementary education is qualified to teach all courses from kindergarten through sixth grade. Middle-level certifications, which allow individuals to teach courses in grades seven through nine, are addressed in CSPG #52 to 55.

Certification Assignment:

An educator holding a valid Pennsylvania certificate for elementary education is qualified to teach mathematics, English language arts, developmental reading, science (including environment and ecology), history, geography, government and other content areas. In addition, elementary education teachers are qualified to teach art, music, business, computer and information technology, health (including AIDS and other health issues) and physical education within a grade-by-grade (K-6) self-contained elementary classroom. The certified elementary educator may teach remedial classes, **other than** diagnostic/prescriptive reading, to students whose grade norms fall below seventh grade. A person holding an elementary education certificate is qualified to teach developmental reading up to and including sixth grade.

The certified elementary educator:

- May teach remedial classes, **other than** diagnostic/prescriptive reading, to students whose grade norms fall below seventh grade;
- Is qualified to teach developmental reading up to and including sixth grade; and
- Is qualified to teach AIDS education within a grade-by-grade (K-6) self-contained basis a certified school nurse may not be assigned as a teacher but may serve as a resource.

When elementary students are grouped separately and scheduled for instruction in any or all of the following areas, a person holding a certificate endorsed in the appropriate area must be assigned:

Content Area	Required Certificate Endorsement
Art	Art
Business, Computer and Information	Business, Computer and Information
Technology	Technology or Business Education
Health	Health or Health and Physical Education
Music	Music Education
Physical Education	Health and Physical Education

Special Considerations:

An educator certified in elementary education may provide staff development services regarding their collegial studies/skills, may serve in the role of mentor or advisor, and may

assist students in understanding the "reading" content area materials related to this subject area.

Restrictions:

A person holding an elementary education (K-6) certificate may be assigned to grades Kindergarten 4, Kindergarten 5 and first through sixth grades. The certification may not be used in a Pre-K Counts program.

A person holding an elementary education certificate may not be assigned as the teacher of record in a computer lab or resource center for the purpose of computer technology instruction effective Sept. 1, 2003. Teachers assigned to computer education classes prior to Sept. 1, 2003, may be retained as long as they remain in those positions. Once a computer education position is vacated, staffing must be in accordance with the guidelines provided relative to CSPG #33.
